Transportation Links	
Buses*	There are 15 bus stops in the village where you can pick up the Tynedale express buses or gonortheast 684 however none of our pupils travel by public bus. There is one bus stop that is under shelter, which is near the main road into Heddon-on-the-Wall. All bus services arrive from Newcastle and they travel onto Carlisle, Keswick and Hexham whilst stopping at local villages on route.
Rail*	Nearest train station is at Wylam approximately 10 mins drive or 20 minutes by bus and none of the pupils travel by rail. Nearest Metro station is at Newcastle Airport and none of the pupils travel by Metro.
Roads*	The school is situated at the end of Trajan Walk, a residential street with no through access. Other roads are Heddon Banks and The Towne Gate which leads on to Military road which connects to the A69, the main arterial road in the west of the county linking with Carlisle to the west and Newcastle to the East

Walking Routes*	The area is well served by a network of paved / tarmacked footpaths.




#### **Pupil Survey Results**



Teachers from the classrooms completed the surveys with the children. Travel issues stated by one member of staff was traffic congestion during journey.

Waiting traffic on High Callerton, at junction with Stamfordham Road / pot holes on country lanes between Stamfordham Road and Heddon A69 slip road

Journey is approx. 20 miles each way taking around 40 mins each way. Other means of travelling to work are impractical.
